### 3. Old business

- Policy on Policies (see document)
  - Resolution from the March meeting: was voted on unanimously by senators
  - Senate document was used to help shape process for Policy on Policies draft
  - Policy is going forward for approval to the Board of Trustees in October (we believe)
  - Integrates Senate's focus on faculty policies with Provost's Office more general policies

### 4. Current business

- Campus activism and University response
  - 4 college resolutions passed by majority vote; 1 tabled: both were shared with all Senators by the President of the Senate; University President's letter was also forwarded to the Senate
  - Senate Executive Committee sent request to the University President for Senate participation in After Action Review (AAR) details of AAR process in document shared with Senate
    - o AAR dates inclusive of College meetings
    - o Call for questions from the floor
    - Support for this as a positive process under exceptional circumstances
  - Discussion of resolutions passed by College faculty
    - Call for discussion, starting with elected Senators
    - College senators met on 5/14 to discuss
      - College senators discussed process: length of meeting, which went over significantly and the fact that the final resolution was not circulated to faculty in advance
      - College senators came to consensus on a resolution: "The Collegiate Senators believe that holding a
        vote of no confidence on the President is premature." This addresses the tabled resolution for the
        College faculty meeting for 5/20
      - Support from the floor for this resolution from outside the College
        - AAR is a useful tool for precisely this kind of situation
      - Discussion in College meeting did not include the perspectives of administrators who made decisions
      - Importance of caring for students who may feel marginalized and unheard
      - Chair of College senators has invited colleagues who were working with students to dialog with College senators
      - Questions of freedom of expression and student conduct: will AAR leave room to discuss other impacts
  - Discussion of President Wente's letter to the campus
    - Letter sent on Tuesday, 5/14 ~3:00 p.m.
    - President received letters from Departments of Religious Studies and Psychology, signed by faculty, on Thursday, 5/9: letters informed President's response
    - Strive for transparency and communication, but certain information cannot be shared for legal and other reasons
    - President has had ongoing meetings with different constituencies with a focus on listening and being responsive

- Commitment to Academic Freedom and Freedom of Expression; equal commitment to concern and care for all
  of our students
- Statement from the floor about taking time for process
- Question from the floor about whether there is concern for any disruptions of Commencement activities
  - Provost: large and thoughtful events team, including Dean Tim Pyatt (Library) and Associate Provost Matthew Phillips; faculty marshals also play an important role
  - Communicating expectations about not disrupting the ceremony and sharing guidelines with students and their families
  - Extra screening at entrance, but this practice is part of a longer-term pre-existing movement towards ensuring all campus events are safer
  - Campus Life staff designated as "speech advocates" who are tasked with helping guide any protest towards designated areas
  - Administration communicating with colleagues at other campuses to ensure that we are prepared
- Statement from the floor about attending to the emotions and history behind the present moment as part of the AAR and ongoing dialog
- 4 senators to serve on AAR
  - Comment that not all information from an AAR may become fully available for legal and other reasons, but it is still a useful tool
- Freedom of Expression/Academic Freedom Task Force Report (see document)
  - Phase One report
  - Encourage senators to read and not avoid the appendices, which includes information from other universities
  - Includes plan for next phase(s)
  - Desire was expressed for more Faculty Senate participation
- Fringe Benefits: Behavioral Health transition (see document)
  - Question for Fringe Benefits Committee about what role committee can play in gathering and sharing feedback. Colleagues were caught off-guard about CBHA change.
  - Fringe Benefits are complicated; a lot of assumptions being made about coverage may not be accurate to assess at this point. Confidentiality can complicate this as negotiations happen.
  - Desire expressed for more and better communication from HR; faculty also have to communicate issues with HR
  - Some healthcare benefits challenges reflect broader regional and national problems
  - Committee was unhappy with HR's communication plan, but were able to influence the communication to get more information to colleagues
- Other Committee Reports
  - Athletics
    - Shared recent successes of student-athletes
    - House case settlement re: NIL may have financial implications; articles linked in report
      - Settlement will have past damages, but University President suggests that media reports may not be entirely accurate about projected amounts
      - Executive Committee will be briefed as information becomes available
      - ACC meetings are underway
        - FSU and Clemson have lawsuits to leave ACC; UNC board may be exploring the option
        - Meetings involved athletic directors and coaching staffs, not university presidents and board members
        - Possible realignment will be a long, drawn-out process
  - Capital Projects (past "Resources")
    - No report
  - College
    - Workload and equity are ongoing conversations with the Dean
  - Integration
    - No report
  - Salaries
    - Summary reports on year-over-year salary and peer comparisons are available
