Dr. Hampson provided a sheet with course recommendations and reviews (as-is, as corrected, major concerns).

- One has to be labelled as a CHANGE. IPP 755 was approved last month; now requesting a number change.
- 5 courses need some corrections.
- Addition research program (ARCH) provided 9-10 courses to "add"; no pre-requisites were listed; so some clarifications are needed
- WGS course descriptions are inadequate; they do not provide sufficient descriptions for a graduate level course.
   We request additional courses. 350/650 course listing is not uncommon, but what will graduate students do? (100 and 200 level are harder to justify at graduate level?)

A motion was made to approve all "As-is" courses (with no concerns listed), was seconded and approved unanimously.

Add pre-req. for ARCH 711 (recommended to approve ARCH 710 and 711)

IPP 728/755 minor correction (it's a change not ADD)

WGS 605, minor corrections regarding course credits

A motion was made to approve all "as-corrected" courses (with minor concerns listed and contingent on those corrections being made administratively), was seconded and approved unanimously.

A motion was made to table 3 WGS courses that need clarification (WGS 616, 617, 650): - needs additional language (courses will be offered in Fall 2018). Requested changes will be emailed to Dr. Hampson prior to April 24<sup>th</sup> and will distributed to sub-committee; once sub-committee has approved, an email polling the entire GC council will be send to approve the courses prior to Fall semester.

Course ARCH 708 was tabled for further clarification (not approved at current time).

#### OTHER BUSINESS

1. Concentration Proposal: Women's, Gender, and Sexuality Studies (Chair of WGS attending)

- There is a growing interest from graduate students in English, Communication, Psychology, Religious studies, Education, etc.
- Could potentially help recruit more graduate students in these departments.
- There is potential for some funding (private sources)
- 12 credit hours proposed for concentration
- Oral presentation is part of the concentration
- Certificate will be provided upon completion signed by the Director of the program

#### **Questions:**

# Q1. What is the time frame? Can they finish this in 2 years?

Yes, they can finish within the period of 2 years in tandem with their primary MA/MS programs. (or tandem with PhD programs), but there was some concern given extra credit load. Could be faster/slower depending on the number of "cross-listed" classes

# **Q2.** How many programs have cross-listed courses with WGS at the present moment? Several, but not all are offered every semester

Note: WGS 616 is not currently approved, but listed in the concentration

A motion was made to approve the WGS concentration, the motion was seconded, and approved unanimously.

# 2. Concentration Proposal: Antimicrobial Stewardship and Infection Prevention (Dr. Bischoff)

- All course have been listed as part of the CPTS program
- Need to provide greater training and education on antimicrobial stewardship and infection prevention, particularly in out-patient settings
- 11 credits proposed for the concentration (7 extra hours, 4 is part of CPTS)
- Global health seminar series (students will have to participate)
- Certificate will be provided upon completion signed by the Director of the program

#### Questions:

# Q1. What is the time frame? Can they finish this in 2 years?

Yes, the CPTS is a two year master's program. These are new "electives" being offered by CPTS.

#### Q2. Is the thesis required for the concentration or is it a part of the CPTS program?

No, thesis is part of CPTS. Students can choose if their thesis will be in the anti-microbial stewardship

# Q3. Is this concentration only for CPTS students? Only MS students?

Not specifically tied to the CPTS program; Biomedical Sciences could be interested. PhD students are allowed to take this concentration.

A motion was made to approve the Antimicrobial Stewardship and Infection Prevention concentration, the motion was seconded, and approved unanimously.

#### 3. Melson Award: Committee Recommendations

Brad Jones chaired the rest of the meeting. Dr. Godwin had a conflict of interest with Melson Award recommendations and removed himself from the meeting room. The Melson review committees spent the last couple of weeks reviewing the applications and have made their decisions on the recipients for the Doctoral and Master awards. The recipients will be announced at Hooding.
