Tim put forward the Couse Change Proposals. Most proposed additions for 600 level courses are where 300 level courses currently exist. Most proposed deletions for 600 level courses are where 300 level courses do no exist.

Most changes are to correct typos with a few exceptions, e.g. HST671, where change proposals are used to bypass add/delete and rename courses and provide new descriptions. It was also put forward that the History department does not have an MS program but the course also support Liberal Studies. All proposals were approved.

Leah McCoy put forward the nominations. The nomination form was sufficient demonstration of a role in graduate education for Drs. Canzona, Greene, Mulcahy and White. Their nominations were approved. Concerns were raised for Dr. Roper. Dwayne was to present this faculty member for nomination but was absent. Dr. Roper is appointed to Student Affairs, co-facilitates the MedPath course and mentors post bac students but does not serve on committees. His nomination will be tabled until the next meeting.

2. Re-credentialing Review Update

Leah McCoy and Graduate Council members reviewed 199 re-credentialing applications. Questions were raised for a subset:

- Ramon Casanova only supplied publications, no indication of teaching, serving on committees or other contributions to graduate education.
- Page West appointed in the School of Business with no activities in the Graduate School
- Mark Jensen appointed in the School of Divinity with no activities in the Graduate School
- Stephen Rapp appointed in the School of Medicine with no activities in the Graduate School

Among applications reviewed to date, ~ 170 were approved, the four listed above will receive follow-up memos to understand the necessity of appointment as Graduate School faculty and ~ 30 are still pending review.

C. Policy Committee (David John, *Chair*)

1. Family Leave Policy

David John provided an update on the progress of formalizing a family leave policy. David and Dwayne met with legal last week and a single policy was recommended. It was openly acknowledged that Wake Forest must comply with federal law, e.g. NIH lays out sick and maternity leave. However, as of today, legal has determined we may need two policies and more research needs to be done. It is currently felt that the policy will not be ready to present more broadly, e.g. graduate students, until the fall.

OTHER BUSINESS

A. Updated Graduate Bulletin Changes for the MA Program in Dept. of Mathematics and Statistics (Stephen Robinson)

Robert Erhardt presented the changes. As outlined, these changes would create two tracks within the Mathematics and Statistics department: Track 1. Mathematics and Track 2. Mathematical Statistics. There are now 9 graduate level courses and the new text would outline/update course requirements. The track distinction would only be made once a student was accepted to the program, i.e. recruitment would not change. The change was approved.

B. Melson Award

Graduate programs on the Reynolda campus have been asked to raise money to support the equivalent of two full time or 10 PTS (part time tuition scholarship). Discussion centered around support of the graduate program, the quality of graduate students being recruited without scholarships, and cost associated with faculty and technicians assuming these teaching roles. Some departments have been able to make up the difference while others are having difficulty. Discussions will continue as to how to make this work.

D. Reynolda Campus Graduate Program Directors Report (see attachments 'Report Summary' and 'Individual Program Reports') (Eric Stone, William Turkett, Martin Guthold)

Eric Stone presented the report which summarizes a lack of financial support for graduate education, e.g. no increase in TA stipends making us less competitive with other programs as well as a new "tax" assessment on graduate student revenue. The document lays out five ways the graduate program contributes to the school: 1) promotes faculty recruitment and retention, 2) contribute to research, 3) participate in undergraduate education, 4) interact with the local community and 5) enhance the University's reputation. This report has been signed by all chairs and program directors. Eric requested the endorsement of the Graduate Council. There was a motion to approve support of the Graduate Education document and it was approved unanimously.
