A motion was made to approve all nominations. The motion was seconded, and approved unanimously.

C. Policy Committee (Tim Howard, *Chair*)

1. Code of conduct - next steps

Tim Howard was absent due to a conflict in meeting schedules. This will be addresses at future meetings.

Would like to see uniform code of conduct/honor codes from undergrads to grads. Non-academic code of conduct could potentially be extended to Honor Council for adjudication. Goals of the Code of Conduct:

- a. Protect health and wellbeing of our students and comply with federal responsibilities transfer to title IX
- b. Need consistent guidelines for BG and Reynolda campus students
- c. Process for addressing violations

OTHER BUSINESS

- **A.** Ellen Kirkman raised the concern regarding the participation of graduate students near completion of their degrees in the Hooding Ceremony. For example, Education majors are currently allowed to participate in the Hooding Ceremony in May even though their program formally ends in August. There is a desire to allow more students to participate in the hooding ceremony (rather than having to wait one full year later). In fact, if students graduate early Fall, it has been noted that few come back the following May to participate in the hooding ceremony. To allow such graduate students (e.g. ABD) to participate in the hooding ceremony, it was suggested that they must get approval from their Department chair, Program Director and Primary Advisor. Other criteria: Be within "x" hours of graduation, or have a final defense date set for the summer. Note that participating in hooding ceremony does not guarantee that you will graduate. The student is still obligated to complete all graduation requirements. In fact, the student will have an asterisk (*) placed after their name in the program to indicate that they have not fully completed their program requirements. This discussion led to several questions, including: "How many students meet these criteria?" and "Will expanding the size significantly prolong the hooding ceremony?" Closing thoughts were to create a uniform policy to ensure fair criteria between graduate programs on both Reynolda and Bowman Gray campuses. Delegate this topic to the Policy subcommittee and put on the agenda for next council meeting (Ellen Kirkman will submit formally worded proposal).
- **B.** The Council would like to continue with the Long Range Planning committee to benefit Graduate Programs. The questionnaire that was developed by the Long Range Planning Committee last year needs to be sent to departments/ program directors. Ellen Kirkman volunteered to remain on committee, and Abdou Lachgar agreed to serve as well. Several more members of the Council will need to be on the committee.
- C. Cancer Biology Concentration Proposal (Steve Kridel)
 Steve presented the proposal for a Cancer Biology concentration. Several groups of students will benefit from this concentration, including MS students in the biomedical sciences department and others. This concentration will recognize students who actually perform cancer biology research and have completed cancer biology curriculum. Cancer Biology is currently in Track 4 MCB, but now have students from IPP & maybe even BME. The concentration will not be added to the diploma but it will be added to transcript and students can put it on their CV.

Certificate is half a MS; concentration is about 9 credit hours. Concentration must be tied to a degree. Addition of this concentration could have some benefit for recruiting more students.

The Graduate Council made a motion to approve the proposal, motion was seconded and approved unanimously.

- **D.** This is the last year for laptops graduate students must have to buy their own. There is still ongoing discussion regarding BYODevice at Bowman Gray.
- **E.** New graduate rep. for IT through the GSA is needed.
