I understand that once I receive confirmation from the Office of Residence Life and Housing that the properties listed on this form have been registered, renewal of the registration is not required for subsequent academic years unless informed otherwise by the University. I further understand that I will be required to notify the Office of Residence Life and Housing prior to July 1st of each year if I would like to remove any properties from the registered housing list. In addition, I understand that any changes to the Wake Forest University Off-Campus Housing Policies will be sent by the University to the e-mail address listed on this form, and that I am required to notify the University of any changes to the e-mail address.
