## 13. **RESEARCH IN PROGRESS**

- 1. The article "What is a Life Worth?", in press, with Campbell University Law Review, is presently being expanded from a different perspective, emphasizing the impact of inequality and demographic variables on the value of wrongful death settlements.
- 2. "African American Medical Students in Changing Academic Contexts" utilizes focus group data from two traditionally white and two historically black medical schools (N=72 African American medical students.
- 3. We are presently coding data from a medical malpractice insurers files (complete data from a three year period). We plan to look at a number of issues, including whether the ritual of the demand and the offer are influenced by demographic and system variables.

## 14. **TEACHING**

This year I taught a new course, "The Social and Legal Context of Medicine", which utilized inter-disciplinary primary sources from both sociology and medical journals. I will continue to work with the members of this class in the spring semester, many of whom have papers that are worthy of presentation and submission for publication consideration.

As I have done for a number of years I have worked with my students to encourage them to present at professional meetings and to work toward possible publication in some cases. The following is the list of students for this year:

Stephanie Bandyk –presented a paper developed from a project in SOC 270, at the Southeastern Sociological Symposium held at Emory, spring, 2014.

Mimi Bergman won the (2014) Himes Award, presented by the North Carolina Sociological Association. she wrote the paper as a senior in an independent study.

Leigh Winters presented a paper (based on a paper written for SOC 316,(spring, 2014) the State Undergraduate Research Symposium and she did so.

Samantha Herrick's research paper from SOC 272, (spring, 2014) was accepted for publication by *Sociation Today*, the journal of the North Carolina Sociological Association, after she did additional work on the paper in the summer after graduation. This paper is now in print.

Katie Huggins presented a paper completed in SOC 272 (spring, 2014) at the Wake Forest Undergraduate Symposium (fall, 2014). She will be abroad in the fall, but plans to do additional work on the paper and submit it for possible publication.

I am presently working with two honors students, Garrett Baker, and Rachel Van Camp. They have kept in touch about their progress over the break and I will continue meeting with each once a week this semester.
