EXCELLENCE IN ADVISING AWARD

The Excellence in Advising award was established in 1988 to recognize outstanding advising in Wake Forest College, especially at the undergraduate lower division level. Supported by the Office of the Dean of the College, the award is both honorary and monetary. Nominations are solicited from all College faculty, staff and students with the award limited to faculty and staff advising in the College.

URECA FACULTY AWARD FOR EXCELLENCE IN MENTORSHIP IN RESEARCH AND CREATIVE WORK

This award is presented annually to two faculty members who demonstrate excellence in the mentoring of undergraduate students. Established and funded by URECA (Undergraduate Research and Creative Activities Center), the award recognizes those faculty members who engage Wake Forest undergraduates outside the classroom and inspire, guide and support the students' intellectual and creative endeavors.

THE AWARD FOR EXCELLENCE IN RESEARCH

This award is presented annually to an outstanding young scholar in the College or School of Business who is either an assistant professor or is in, at latest, his or her fourth year as an associate professor. The prize for this award is made possible through support from the Alumni Association.

DONALD O. SCHOONMAKER FACULTY AWARD FOR COMMUNITY SERVICE

This award was established in 1988 by the Wake Forest Alumni Council to recognize extraordinary community service of a respected teacher-scholar from the College or School of Business. The award was named in memory of Donald Schoonmaker ('60), professor of politics. Dr. Schoonmaker was posthumously awarded the faculty prize for community service in 1993.

JON REINHARDT AWARD FOR DISTINGUISHED TEACHING

This award recognizes an experienced member of the faculty, distinguished as a teacher in the broadest sense of the word, and recognized not only for performance in the classroom but also for exemplifying the ideals of a liberal arts education. To be considered for the award, faculty members must have held the rank of associate or full professor, or its equivalent, for at least a year.

THE JOSEPH BRANCH EXCELLENCE IN TEACHING AWARD

This award was established in 1985 to honor Chief Justice Joseph Branch (JD '38, LLD '83) upon his retirement from the North Carolina Supreme Court. Recipients are chosen from the School of Law faculty on the basis of outstanding teaching and service to the legal profession.

THE KULYNYCH FAMILY OMICRON DELTA KAPPA AWARD

This award was established in 1982 by the Wake Forest Circle of Omicron Delta Kappa to recognize an outstanding faculty member who bridges the gap between classroom and student life. The recipient must contribute beyond the expected duties of teaching and research. In 1997, the award was endowed by the Kulynych Family Foundation and the name was changed to honor the Kulynych family.

THE REID-DOYLE PRIZE FOR EXCELLENCE IN TEACHING

This award is for faculty members in the College and School of Business who are still in the early part of their careers. The award was established in 1971 and renamed in 1986 in recognition of the generosity of the late Wilbur Doyle ('48), who endowed the prize to honor his philosophy professor, A.C. Reid. The Reid-Doyle Prize is also supported by the Alumni Council and the Alumni Association.

SENIOR ORATIONS

Wake Forest Institute, founded in 1834, was re-chartered as Wake Forest College in 1838. From the very beginning, students organized and expanded debating and literary societies and promoted "oratory" at special occasions of the College. This annual tradition has included senior orators with such familiar names as Poteat, Kitchin, Worrell, Hankins, Paschal, Royall, Wingate, Folk, Wilson and Christman. In 1946, Nancy Hyde Easley became the first female senior orator.



THE MEDALLION OF MERIT

The Medallion of Merit is the highest honor given by Wake Forest and is presented annually for outstanding achievement and distinguished contribution to the University. Previous recipients include presidents of the University, trustees, benefactors, and retired faculty and administrators.

Founded in 1834 by the Baptist State Convention of North Carolina, Wake Forest Institute opened on February 3, 1834, on the Calvin Jones plantation in Wake County, North Carolina. Principal Samuel Wait welcomed 16 students that first year. Four years later, the school was rechartered as Wake Forest College.

The School of Law was founded in 1894, followed by the opening of a twoyear medical school in 1902. The medical school moved to Winston-Salem in 1941 to become associated with the North Carolina Baptist Hospital and was named the Bowman Gray School of Medicine.

In 1946, the Z. Smith Reynolds Foundation offered significant ongoing financial support to move the rest of the College to Winston-Salem. Charles and Mary Reynolds Babcock donated much of the R.J. Reynolds family estate as the site for the new campus. Following the groundbreaking in 1951, the first 14 buildings were constructed during the next five years. The move to Winston-Salem took place during the summer of 1956.

Wake Forest was exclusively a college for men until World War II, when women were admitted for the first time. The trustees voted to end segregation in 1961. That same year, the Graduate School of Arts and Sciences was established. Wake Forest achieved university status in 1967.

The Babcock Graduate School of Management opened in 1969 and added the Charlotte campus in 1995. The undergraduate program in business and accountancy, which began in 1948, was reconstituted as the School of Business and Accountancy in 1980. The school was named in honor of Board of Trustees Chair Wayne Calloway ('59, LLD '88) in 1995. In 2009, the two schools merged to become the Wake Forest School of Business.

The medical school was renamed the Wake Forest University School of Medicine in 1997 to more closely reflect its affiliation with the University. The School of Divinity opened in 1999.

CARILLON PRELUDE

"In Fantasia on a Theme of Wake Forest, I wanted to make a sonic symbol of Wake Forest that could be played on the Harris carillon, an iconic installation of the campus soundscape. I decided to write the word "WAKE" in musical notes. 'A' and 'E' are easy enough to find on the keyboard, but 'W' and 'K' are not naturally occurring in the scales of Western music. However, I found that if I started at the lowest 'A' on the keyboard and moved up by a step, making each key correspond to a letter of the alphabet, the letter 'W' landed on the pitch B and 'K' landed on the pitch D; the letters 'A' and 'E' could simply correspond to the pitches with the same name. Suddenly, I had a melodic fragment: B—A—D—E. More significant than a fragment, though, the fantasia is based on only those four pitches. Thus, this fantasia is Wake Forest from beginning to end."
