Align Program with Organizational Goals 3

Highlight Mutual Benefits

Emphasize how your advanced legal knowledge will contribute to more informed decision-making, improved compliance, and an understanding of legal implications of decisions for your company.

Address Potential Concerns 5

Reassure your employer of your commitment to your role, emphasizing that the program's flexibility means your work performance will not suffer.

Sample Talking Points for Your Proposal
