Proposed revisions to Student Code of Conduct

12. Disorderly Conduct. Conduct that is ~~disorderly~~ violent, threatening, or lewd. ~~or indecent; breach of peace.~~

13. Disruption or Obstruction of University Activities. ~~Substantial~~ Disruption or obstruction of any University activity and/or other authorized non-University activities ~~in a violent or threatening manner, which occur~~ on or off campus. ~~Disruptive or obstructive actions include but are not limited to: preventing an instructor or speaker from giving a lecture, by means of shouts, interruptions, chants or other verbal or audible means; interfering with the audience's view of an instructor or speaker; preventing members of the university community from participating in class, hearing a lecture or taking an examination; disrupting business operations of the university; disrupting use of or access to libraries or residential housing; obstructing passage within, into, or out of buildings; interfering with prospective student or employer recruitment or university activities for alumni, parents or other invited guests; refusing to leave a closed meeting when unauthorized to attend; and preventing free pedestrian or vehicular movement onto or about campus.~~

APPENDIX B

Proposed revisions to Senate bylaws

Note: original text is in black type; revisions approved by the Faculty Senate at their meeting of 15 November 2017 are in red type.

Article II

Section 3. Eligibility for Elected Membership.

Senators must have the rank of Associate Professor, ~~Associate Teaching Professor, Associate Professor of the Practice, Associate Librarian, Associate Teaching Librarian~~ or higher, or the equivalent (as determined by the individual academic unit). In the event of a question regarding the eligibility of an elected representative, the Senate will decide the issue of eligibility. The Executive Committee shall present a motion to resolve the conflict to the body at the next Senate meeting

Article III

Section 6. Additional Appointments.

The Senate President shall appoint Senate representatives to the University Finance Advisory Committee. The representatives shall include the President, the immediate past President, the Chair of the Resources Committee, a representative of the College and Graduate School, and a representative of the professional schools.

The Senate President shall also appoint Senate representative(s) to other advisory committees and bodies as requested by relevant officials or deemed appropriate by the Senate. Typically these bodies shall include the University Parking and Transportation Committee, the Capital Planning Committee, and the Staff Advisory Council.

The process for selection of faculty members to be submitted to the Committee on Trustees will be as follows:

1. Academic Committee

a. Graduate and Professional Schools Representative

The senior Faculty Senator from each of the schools will constitute a committee which will select a chair and a vice chair. (If the senior Senator is a representative to another Board committee, the junior senator will serve as a member of this committee.) The chair, and in the absence of the chair, the vice chair, will meet with the Board committee pursuant to trustee approval.

b. College Representative

The chair (and as an alternate the vice chair) of the College's Academic Planning Committee will serve as the representative to the Board's Academic Committee pursuant to trustee approval.

2. Athletics Committee

The chair (and as an alternate the vice chair) of the College's Athletics Committee will serve as the representative to the Board's Athletics Committee pursuant to trustee approval.

3. Student Life Committee

The chair (and as an alternate the vice chair) of the College's Student Life Committee will serve as the representative to the Board's Student Life Committee pursuant to trustee approval.

4. Administration Committee, Advancement and Communications Committee, Finance Committee

The University Senate's Executive Committee will select a representative, pursuant to trustee approval, to attend each of these three Board committees.

At the beginning of the academic year, the Senate President shall name a representative from each academic unit to be a communications liaison. It shall be the responsibility of each communications liaison to give regular reports to the academic unit about Senate business.

Article III

Section 6. Additional Appointments.

The Senate President shall appoint Senate representatives to the University Finance Advisory Committee. The representatives shall include the President, the immediate past President, the Chair of the Resources Committee, a representative of the College and Graduate School, and a representative of the professional schools.
